
4:34 – Tom informed the board of a neighbor he has that is living in a camper, presumably illegally. Tom asked about town rules and how they get enforced.

2:09 – Garry gave an update on the highway dept.


2:18 – Garry had an update for Samantha to give to the Dyers:

2:21 – Discussion about FEMA work.


2:26 – Discussion on junkyards.
