4:41 – David Pardy discussed a flooded "pond" in front of his property on Britton Rd he believes was caused by the grader.


4:43 – Garry informed the room about the meeting with the insulation company for the highway shed. After their discussion, the company lowered the bill from \$10,100 to \$7,256.

4:44 – Bill made a motion to accept the Sheriff's department contract. Gary 2nd. All in favor.


4:45 – Garry read an FYI about a 911 violation. The first offense fine for that person comes into effect.

4:49 – Garry made a motion to pay \$1,360.00 to ADE Construction, \$586.68 to Twin State Garage Door, \$1,932.21 to ADE Construction, \$945.00 to Twin State Garage Door, and \$340.00 to ADE Construction. All to come out of a previous highway shed construction refund from Depot Home Center. Bill 2nd. All in favor.

4:51 – Garry gave Paul a health officer form to sign.

4:53 – Bruce Adams brought up the need for a Knox box on the new highway shed.

4:59 – David Pardy gave an update from the planning board. He also asked about the National Flood Plan, StARR, that the town voted on in 2006. Further discussion and questions on flood insurance followed. David also asked about logging permits and abutters.


